

Policies and Procedure for usage of Brewer Park Soccer Fields:

1. **Remind all teams to Pick Up Their Trash.**
Not only is littering illegal in Kent County, it is un-neighborly to the people who live around the fields. There is also a \$25 fine imposed for trash left on the field after a game (which includes athletic tape) . This fine is assessed to the home team. Everyone should do their part to keep the fields clean including the teams to the spectators.
2. **Brewer Park Committee will paint the fields – NO OTHER GROUP MAY PAINT, CHALK, OR MARK THE SOCCER FIELDS IN ANY FASHION WITHOUT PREVIOUS PERMISSION FROM THE BREWER PARK COMMITTEE.**
3. **NO TAPE OF ANY KIND WILL BE USED ON THE GOALS.** Only Zip ties or Velcro straps are to be used to hang the nets.
4. **Dogs are not allowed past the parking lot at anytime by the fields.** This includes the south ends of the fields. Not only is this for practical reasons such as clean-up but also for liability reasons as well. Any dog, no matter how good, can turn on a moment's notice. This also includes dogs that are held. Team managers need to inform their visiting teams of this condition so there is no misunderstanding.
5. Parents need to be watchful of their children who are not playing soccer. Any damage to either the nets, goals, sprinkler heads, other Brewer Park Soccer property or Kent County Parks property will be charged to the home team should it proven that the damage was caused by spectators (or unsupervised children) or players.
6. Restrooms are located by the playground at the shelter. Port-a-Johns are provided at the field. Anyone observed not using either one by County Park Personnel or the Field Person will be asked to leave immediately—whether they are a player on a team or not. **No exceptions.**
7. **Due to the closeness of homes to the fields, air horns, loud music and excessive noise are prohibited.**

As there is a large demand for the usage of the fields and games/leagues are consistently being turned away the following policy has been initiated:

8. **Game Fee Refund Policy:**
 - A. All games are paid in advance of play.
 - B. If a game is canceled for any reason other than weather less than 48 hours in advance: no refund will be issued.
 - C. If games or age group of games are canceled by the beginning of the 2nd week of the season and payment has been received in full, full refund can be issued for the games that are canceled.
 - D. If games or age group of games are canceled after the beginning of the 2nd week of the season but before the end of the 3rd week, ½ of the fee prepaid can be refunded.
 - E. If games or age group of games are canceled after the 3rd week, no refund will be issued.
 - F. This policy is for the cancellation of games due to reasons other than weather or field conditions.
