**ALL PLAYERS**

1. 2. **If you decline to play in the division (and on the nights) in which you are drafted, your registration fee will not be refunded.**
3. The deadline for HCSSL receipt of registrations is March 10, 2012. Registrations received after this date will be charged a late fee of \$30.00 and may not be processed for the player draft. Registrations received after March 13, 2012 will not be processed for the player draft. Assignments to teams will then be made according to League guidelines regarding Late Registering Players.
4. Registrations received without the correct fee will not be considered as received and will not be valid until the correct fee is received.
5. United & National divisions play on Monday & Wednesday; American & Continental divisions play on Tuesday & Thursday.

**RETURNING PLAYERS**

1. Players who have not played in the previous HCSSL Summer or Winter Season (2011) are required to attend the evaluation session on **Saturday, March 3 rd** from 8:30 to 11:30 a.m. at Bayland Park Senior Softball Field # 2. If you do not attend, you will not be eligible for the draft and will be assigned to teams in accordance with HCSSL's guidelines regarding Late Registering Players.
2. **There is no guarantee you will play in the division in which you played last year.**
