



The Mundelein Junior Football League (MJFL) would like you to join us at the 2009 MUNDELEIN MAGIC CHEER COMPETITION. Our competition will be held on Sunday, November 15, 2009 at Lake Zurich High School located at 300 Church Street, Lake Zurich, Illinois 60047.

2009 MUNDELEIN MAGIC CHEER COMPETITION will include both cheer and pom divisions. The competition is open to all youth recreation leagues, park district and school teams. This is an excellent opportunity for your squad to have fun and compete with the area's finest athletes.

Check-in time begins at 7:30am; squads must check-in no later than one hour before their scheduled performance time. Competition begins at 9:00am. An email confirmation will be sent to you approximately one week prior to competition. This notification will include your performance time and any last minute information. In the 4<sup>th</sup> Grade to 8<sup>th</sup> Grade categories, team awards will be presented for all 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> place teams, with individual awards for these places as well. All participants in the Exhibition Category, 3<sup>rd</sup> grade and lower, will receive trophies.

IRCA STATE CHAMPIONSHIP. This event will be an IRCA Sanctioned Event. All teams that score a first place in their division/category, will automatically receive an invite and a first-round bye to the IRCA State Championship. Solo performers must score 78% to receive an invite and first-round by to the State Championship.

Exhibitions teams (k-3<sup>rd</sup> grade) that score a 78% point value will also receive an invite – The State Championship will be a competitive format though!

Team score sheets will be provided from the judges.

The 2009 MUNDELEIN MAGIC CHEER COMPETITION registration packet includes registration form, roster and waiver forms. Please ensure you review all information provided.

Divisions will take a limited number of squads, so please register early to secure your entry. The deadline to register your team(s) and participants is early November 2009.

# MUNDELEIN MAGIC 2009

## **GENERAL COMPETITION INFORMATION & GUIDELINES**

1. Each participant must be an official member of the registered squad. Coaches, Jr. Coaches, Team Managers checked-in will wear name tags designating them as such when arriving with entire team at check-in and throughout the building and competition.
2. All cheerleading and pom squads must have at least six (6) members on the squad with a maximum of 35 girls on the squad.
3. Each squad must be under the supervision of a Coach, Jr. Coach, Team Manager and/or other responsible adult throughout the competition. Coaching staff of squad will be responsible for their squad's conduct at all times.
4. Unsportsmanlike conduct will not be tolerated. Coach, Jr. Coach, Team Manager, parents and participants must not commit any unsportsmanlike act, this includes but is not limited to, acts or conduct such as:
  - a. Disrespectfully addressing or contacting an official or gesturing in such manner as to indicate resentment;
  - b. Using profane or inappropriate language or gestures;
  - c. Baiting or taunting an opponent. Any form of taunting which is intended or designated to embarrass, ridicule or demean others under any circumstances, including on the basis of race, religion, gender, or national origin;
  - d. A Coach, Jr. Coach, Team Manager, neither parents nor participants shall use tobacco or smokeless tobacco or be under the influence of alcohol or illegal drugs.
5. No jewelry or body piercing will be allowed (25 point penalty). The sole exception will be made for religious or medical medals; however, they must be taped to the body without a chain under the apparel.
6. No glitter of any sort is allowed (15 point penalty). Make-up is allowed.
7. Fingernails should be at an appropriate length, not visible when viewing from the palm side. No fingernail polish (15 point penalty).
8. No mascots will be allowed to perform (25 point penalty if this occurs). Fans and spectators in the stands are encouraged to support the teams in a fun yet respectful manner. Fan participation cheers, costumes and signs are welcomed as long as they do not interfere with other spectators viewing.
9. Non-performing teams must remain orderly and quiet while other teams are performing or a 25 point penalty will be deducted from your score.
10. Coaching staff or audience members are not allowed to prompt during a squad's performance. This includes all teams participating in this competition except those in the exhibition division. Prompting includes facial gestures or hand signals and will result in penalty points taken from the score (25 points penalty).
11. All performances must be appropriate for family viewing. Any offensive or suggestive movements, hand gestures, words or music could result in an unsportsmanlike penalty (25 point penalty).
12. Score sheet can be picked-up after each division. Head coach's initials are required next to any changes or penalty points.
13. Supports, braces, etc. which are hard and unyielding or have rough edges or surfaces must be appropriately covered. A participant wearing a cast must not be involved in a stunt.

Failure to comply with these rules and regulations will result in point deductions or disqualification at the discretion of the judges.
