Waiver of Liability

By signing below the parent/guardian agrees:

In return for my child ("Participant") being allowed to participate in the NFL FLAG football program (the "Program"), I release and agree not to sue Thunder Alley Football, Kids Zone Youth Sports the National Football League, its member professional football teams, NFL Properties LLC, NFL Ventures L.P., and their employees, sub-contractors, sponsors, including agents, and affiliates, and subsidiaries (collectively, the "NFL Entities") from all present and future claims that may be made by the Participant or me, my family, estate, heirs, or assigns for property damage, personal injury, or wrongful death arising as a result of the Participant's participation in the Program, wherever, whenever, or however the same may occur. I understand and agree that those listed above are not responsible for any injury or property damage arising out of the Program, even if caused by their ordinary negligence. I understand that participation in the Program involves certain risks, including, but not limited to, serious injury. I am voluntarily allowing Participant to participate in the Program with knowledge of the danger involved and agree to accept all risks of such participation. I certify that the Participant is in excellent physical health, and may participate in strenuous and hazardous physical activities, including the football to be played in the Program. Permission is granted for Participant to receive emergency medical treatment, if needed. I also agree to indemnify and hold harmless those listed above for all claims arising out of Participant's participation in the Program and all related activities. I agree to let the parties use Participant's name and likeness free of charge in any manner and for any purpose without compensation to me or Participant. I understand that this document is intended to be as broad and inclusive as permitted by the laws of the state in which the Program is taking place and agree that if any portion of this Agreement is invalid, the remainder will continue in full legal force and effect. I further agree that any legal proceedings related to this waiver will take place in New York, New York.

I further agree that the player and I will abide by all the rules, regulations and the Parent Code of Conduct of Thunder Alley Football/Kids Zone Youth Sports. In consideration of my child's participation in the program, I, for myself and the player hereby release and indemnify Thunder Alley Football, Kids Zone Youth Sports, their staff, officers, owners along with the owners and operators of any facilities used for practices and games from and against any and all claims, liabilities, damages or cause of action arising with the child's participation in the program. I also understand, acknowledge and agree that there are no refunds for any reason. I hereby acknowledge and consent that photo's may be taken of my child during a game or event and may be used on the Thunder Alley Football or Kids Zone Youth Sports website.

I am the parent or legal guardian of the Participant. I am of legal age and am freely signing this Agreement. I have read this form and understand that by signing this form, I am giving up legal rights and remedies.
