Juniors: All High School and junior-age athletes are invited to participate in the Three Position Air Rifle Match through August 31<sup>st</sup> of their Senior Year. This CMP Cup sanctioned event is being conducted to celebrate the end of the competition year and to welcome in all the new competitors for the upcoming season. Coaches are especially encouraged to bring their “incoming” athletes to compete and/or to observe how the match is conducted.

Open: All athletes not falling into the junior category are invited to compete in the open category.

Three Position Small bore, International Air Rifle and Air Pistol are USA Shooting sanctioned and will be conducted using current USA Shooting Rules.

BB Gun is a non-sanctioned fun match in preparation for the Georgia Invitational BB Gun Championship to be held in September.

### Three Position Air Rifle Match

- Equipment classes:** PRECISION Air Rifle  
SPORTER Air Rifle  
Compressed air is available at the range. CO2 is NOT available at the range.
- Course of Fire:** All athletes will fire a 60 shot three-position event (3x20)  
  
20 shots in each position of prone (20 minutes), standing (25 minutes) and kneeling (20 minutes).
- Targets:** MegaLink electronic targets will be used.
- Rules:** The Current National Standard Three-Position Air Rifle Rule Book will apply.
- Team Composition:** Four Person Teams must be declared prior to the first shot by any competitor on the Team. Team composition will be according to appropriate rule per competition.

### International Standing Match

- Equipment classes:** PRECISION Air Rifle  
SPORTER Air Rifle  
Compressed air is available at the range. CO2 is NOT available at the range.
- Course of Fire:** Men and women will fire a 60 shot event with a block time of 75 minutes.
- Targets:** MegaLink electronic targets will be used.
- Rules:** Current USA Shooting rules apply.
- Team Composition:** Four person teams must be declared prior to the first shot by any competitor on the team. Team composition will be according to appropriate rule per competition.
- Groups/Categories:**  
There are different age groups for competitors (based on athlete age as of Dec. 31, 2017).

### Air Pistol Match.

**Course of Fire:** Men and women will fire a 60 shot event with a block time of 75 minutes.  
PPP athletes will fire a 40 shot event with a block time of 50 minutes.

**Targets:** MegaLink electronic targets will be used.

**Rules:** Current USA Shooting rules apply.

**Team Composition:** Four person teams must be declared prior to the first shot by any competitor on the team.  
Team composition will be according to appropriate rule per competition.

**Groups/Categories:**

There are different age groups for competitors (based on athlete age as of Dec. 31, 2017).

Junior (**J**) – ages 20 years or younger; competitors born from 1997 or later

Open (**O**) – ages 21 or over; competitors born from 1996 or earlier

Disabled (**D**)

There are different categories Progressive Position Pistol (PPP) competitors (based on Current PPP rules):

- Basic Supported (BS)
- Standing Supported (SS)
- SubJunior International (SJI)
- International Standing (IS)

### Three Position Smallbore Match

**Equipment classes:** This is an indoor 50-foot, 3x20 match. Spot checks of equipment may be conducted by Match Officials as needed.

**Course of Fire:** 3x20; 20 shots in each position of kneeling, prone, standing  
There will be a combined 15 minute prep and sighting period prior to firing followed by 120 block time.

**Ammunition:** Standard velocity .22 LR ammunition only.

**Targets:** 10 bull VIS paper targets for the Orion scoring system will be used.  
Match scores will be posted as soon as possible after the last competition shot is fired.  
A 10-minute challenge period will be observed.  
There will be a \$3.00 per challenge fee charged for this match.

**Rules:** Current USA Shooting Rules

**Team Composition:** Four Person Teams must be declared prior to the first shot by any competitor on the Team. Team composition will be according to appropriate rule per competition.

**Groups/Categories:**  
There are different age groups for competitors (based on athlete age as of Dec. 31, 2017).  
Junior (**J**) – ages 20 years or younger; competitors born from 1997 or later  
Open (**O**) – ages 21 or over; competitors born from 1996 or earlier

## **4P BB Gun Match (BB)**

Course of Fire: This is a non-sanctioned indoor 5 meter, 4X10 match. Spot checks of equipment may be conducted by Match Officials as needed. All athletes will shoot a ten shot final.

2 minute prep period before prone. 1 minute prep period before all other positions.  
10 shots in each position of prone (10 minutes), standing (10 minutes),  
sitting (10 Minutes), and kneeling (10 minutes).

- Each Athlete must have a coach on the line.
- Unlimited sighting shots may be fired on a single bull VIS paper target before starting record shots in each position.

Targets: VIS paper targets for the Orion scoring system will be used.  
Match scores will be posted as soon as possible after the last competition shot is fired.

A 10-minute challenge period will be observed.

There will be a \$3.00 per challenge fee charged for this match.

Rules: Current 4X10 NRA BB Gun Rules.

Team Composition: Four Person Teams must be declared and paid prior to the first shot by any competitor on the Team. Team composition will be according to appropriate rule per competition

Groups/Categories: There are different age groups for competitors  
(based on athlete age as of competition date).

Junior (**J**) – ages 15 years or younger

Open (**O**) – ages 16 or over

**Undersigned** agree to indemnify, hold harmless, and defend **Club** from any and all fault, liabilities, costs, expenses, claims, demands, and/or lawsuits arising out of, related to, or in any way connected with, any and all actual or alleged acts or omissions of **Undersigned** in the course of **Undersigned’s** presence on and/or use of **Club’s** range, buildings, facilities, and land (together comprising “Premises”) including, but not limited to, **Undersigned’s** use of firearms.

**Undersigned** further waive for themselves and for their heirs, next of kin, assignees, personal representatives, administrators, and executors any and all rights and claims for damages, loss, costs, demands, and any other actions or claims whatsoever, which they may have or which may arise against **Club** (including, but not limited to, damage to **Undersigned’s** property and/or any and all illnesses, injuries, including mental or emotional distress or anguish, and other damages, including death, suffered by **Undersigned**) which may in any way whatsoever arise out of, be related to, or be connected with use of firearms on **Club Premises** by **Undersigned** and/or another.

**Club** shall not be liable for, and **Undersigned**, on behalf of themselves and on behalf of their heirs, next of kin, assignees, personal representatives, administrators, and executors, expressly release **Club** and **Club’s** members, employees, and/or agents from any and all such claims and liabilities including, but not limited to, claims of actual or alleged negligence on the part of **Club**, its members, employees, and/or agents.

**Undersigned** acknowledge and agree that use of firearms is an inherently dangerous activity. **Undersigned** expressly assume the risk of being on **Club Premises** where firearms are used; and **Undersigned** further expressly assume the risk of discharging firearms by whomever discharged and the firing of live ammunition by them and/or another.

**Undersigned** expressly agree that this agreement by them, individually and together, is intended to be as broad and inclusive as permitted by law and that if any provision of this agreement is held invalid or otherwise unenforceable, the enforceability of the remaining provisions shall not be impaired. No remedy conferred by any of the specific provisions of this agreement is intended to be exclusive of any other remedy, and each and every remedy shall be cumulative and shall be in addition to every other remedy now or hereafter existing at law or in equity or by statute or otherwise. The election of any one or more remedy hereunder by **Club** shall not constitute any waiver of **Club’s** right to pursue other available remedies. This agreement binds **Undersigned** and their heirs, next of kin, assignees, personal representatives, administrators, and executors.

**Undersigned** acknowledge and agree that **Undersigned** have read this agreement and they understand its terms and are executing this agreement voluntarily. **Undersigned** also acknowledge and agree that they have read, understand, and will at all times abide by all range rules and procedures and any other rules and procedures stated by **Club**.
