

**BACKGROUND CHECK INFORMATION SHEET
FOR ALL TCR FOOTBALL AND CHEERLEADING VOLUNTEERS**

Thank you for your interest in volunteering with the Trophy Club - Roanoke Football and Cheerleading Association. TCR is an all-volunteer, non-profit corporation providing youth football and cheerleading programs in the greater Northwest Tarrant County area. One of our primary goals is to continually ensure the safety of our membership.

The TCR Board of Directors passed a resolution requiring all Head Coaches, Assistant Coaches, and members of the Board of Directors to consent to a personal criminal background check to be completed by a reputable company licensed by the State of Texas to conduct such searches. Information obtained from these searches shall be available to TCR Executive Board Members only and shall remain confidential at all times. TCR will pay the cost of each search. The TCR Executive Board of Directors shall have the final decision on all TCR personnel matters.

A person will be disqualified and prohibited from serving as a volunteer in the Trophy Club - Roanoke Football and Cheerleading Association if the person:

1. Fails to consent to a personal criminal background search; or
2. Has been convicted (including crimes whereby a plea of "no contest" was entered) of a crime of child abuse, sexual assault, child neglect, murder, voluntary manslaughter, felony assault, arson, robbery, burglary, indecent exposure, public lewdness, terrorist threat, any offense against a minor, kidnapping, or felony violations of the Controlled Substance Act; or
3. Has been twice convicted, in any combination, of the following offenses: Misdemeanor Assault, or any violation of the Controlled Substance Act; or
4. Has been twice convicted, in any combination during the past seven years, of the following offenses: Driving While Intoxicated (DWI) or Driving Under Influence (DUI); or
5. Has been adjudged liable for civil penalties or damages involving sexual or physical abuse of children; or
6. Has been subject to any court order involving any sexual abuse of physical abuse of a minor, including but not limited to domestic order for protection;

**CRIMINAL BACKGROUND CHECK
WAIVER FORM**

I have read the "Background Check Information Sheet" provided to me by the Trophy Club - Roanoke Football and Cheerleading Association and fully understand the requirements for volunteering for the organization. I hereby authorize the TCR and/or its authorized agent to conduct a criminal background check of my personal history for purposes of evaluating my ability to serve as a volunteer.

I certify that, to the best of my knowledge, all of the information on this form is true and complete. I further certify that I have not withheld any information that would affect my ability to serve as a volunteer. I understand that any omission of crimes or misrepresentation will result in my elimination from consideration of any volunteer or staff position with TCR.

Criminal history records, as received from reporting agencies, may include arrest and conviction data as well as plea bargains and deferred adjudications. I acknowledge that this information will be used to determine my eligibility for a volunteer/staff position. I understand that as long as I am in a volunteer/staff position for TCR, the criminal history record check may be repeated at any time. I further understand that I will have an opportunity to review the criminal history and procedure for clarification if I dispute the record as received. I hereby waive any right to assert that such investigations constitute an invasion of my privacy. I, as the undersigned, do, for myself, my heirs, executors and administrators, hereby remise, release and forever discharge and agree to indemnify and hold harmless the officers, directors, employees, volunteers, agents, and representatives of the TCR, as well as any third parties that TCR or its affiliates contact either directly or indirectly regarding my request to volunteer, against any and all causes of action, lawsuits, liabilities, costs, debts and sums of money, claims and demands whatsoever, and any and all related attorneys fees, court costs, and other expenses resulting from the investigation of my background in connection with becoming a volunteer/staff member. I understand that my service can be modified or terminated, with or without notice or cause, at any time, at the option of either TCR or its affiliates. I understand and agree that TCR or its affiliates may, in their sole discretion, decline to accept this application for volunteer/staff services with or without cause.
