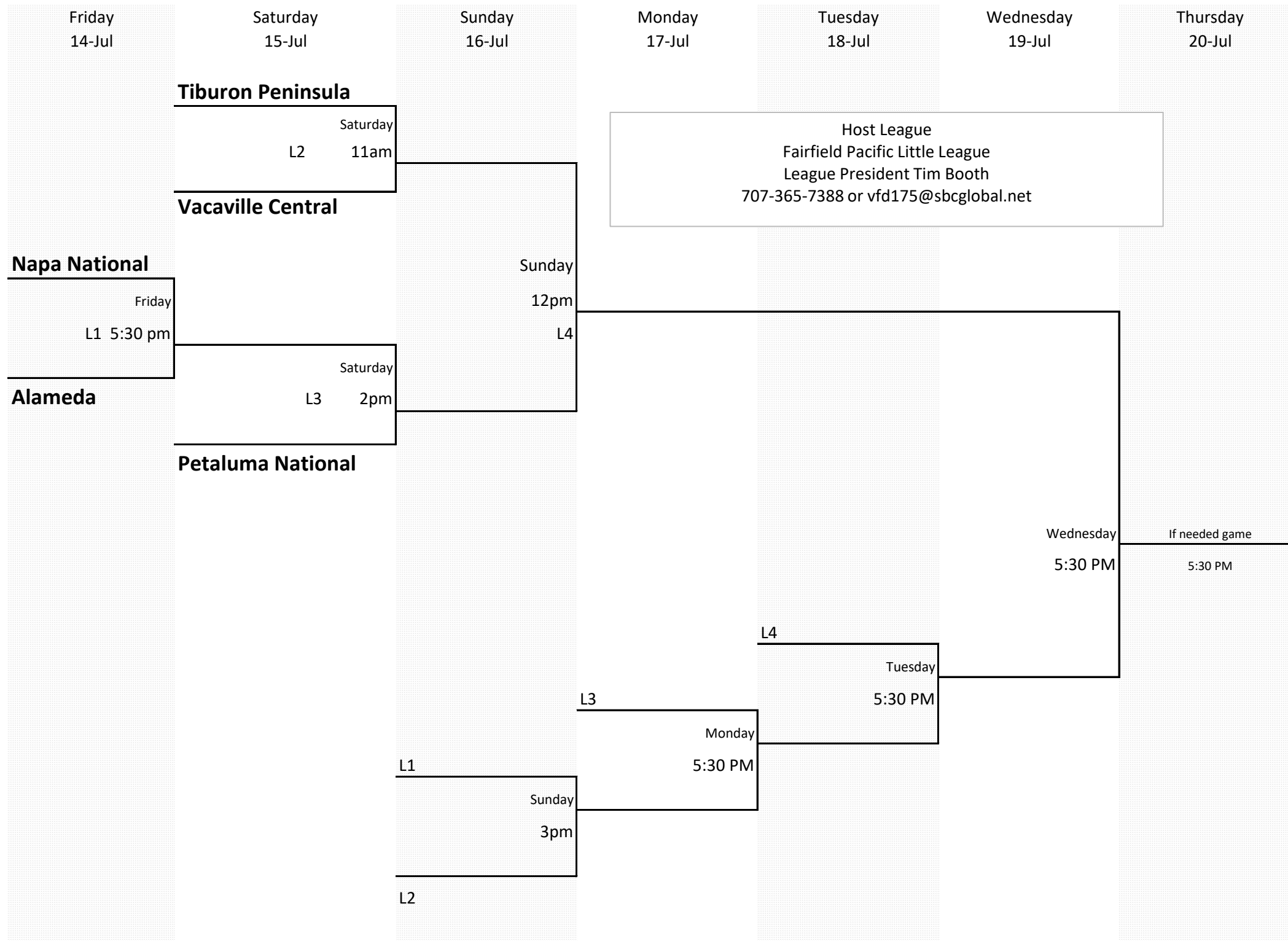

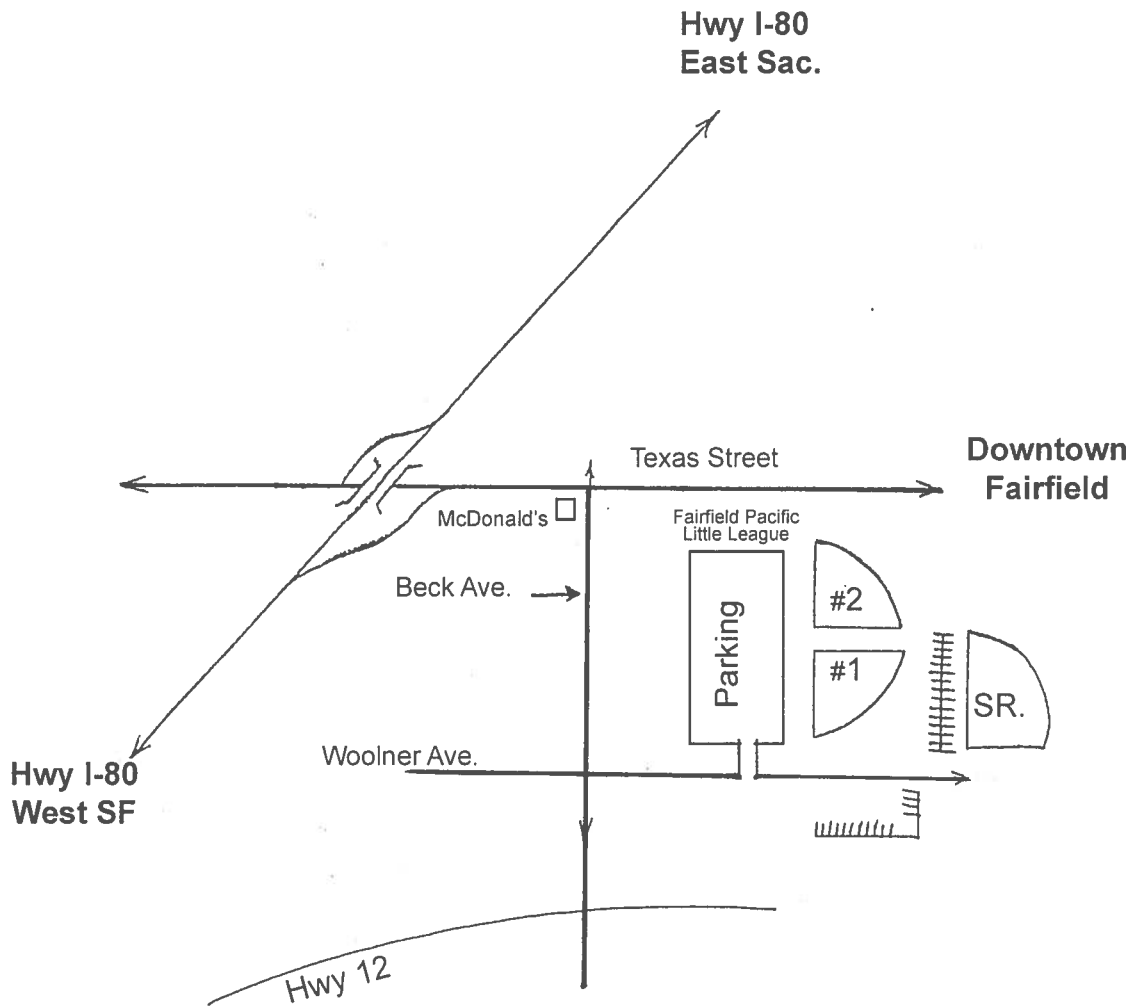

MANAGER'S TOURNAMENT GUIDELINES 2017

- Check in with the tournament Director as soon as you arrive at the field.
- Teams will be at their respective fields one (1) hour prior to game time. Do not enter the dugouts or playing field until you are instructed by the tournament Director.
- All fields are considered neutral. Home team will be determined by the flip of a coin one (1) hour before game time. The host league does all field assignments.
- All equipment will be inspected by the tournament staff. Any equipment that does not meet with the requirements of Little League Baseball or the tournament staff needs to be removed from the park.
- All male players will wear athletic supporters. Catchers must wear a fiber or plastic cup, catcher must wear a mask and approved catcher's helmet during games and practice.
- All managers/coaches are asked to dress appropriately, dress shorts and slacks are encouraged, sandals, open end shoes and baseball cleats are not permitted, think safety.
- After each game the manager is responsible to confirm the number of pitches thrown by each pitcher for that game, manager is required to check in at the end of each game.
- Tournament rules will be strictly enforced. Unsportsmanship conduct and abuse of any Little League Official will not be tolerated, may result in removal from the tournament.
- Team managers must have their tournament affidavit and medical release forms from each team member and a boundary map with player's residence identified in a binder if possible.
- Only team members, coaches and managers on the affidavit will be allowed in the dugout or the playing field at all times including warm up.
- Each team must have approved Little League equipment
- Altercations: Any player, manager, coach or official who is involved in a physical or verbal altercation at the game site could be suspended or removed from the tournament by the Tournament Committee
